## Applicant's undertaking

We hereby apply for inspection of our pulp as raw material for Nordic Ecolabelled paper based products. The status of inspected pulp can be used in merchandising purposes towards paper mills.

If application is for listing on the Nordic Ecolabelling website, the inspected pulp will be listed at the list of Inspected pulps. Trade name of the pulp, type and production site will appear on the lists. Confidential information is not disclosed. If listed in My Swan Account the inspected pulps are listed in Nordic Ecolabelling's database and they are visible for paper applicants only.

Please observe that the inspection of pulp only indicates that Nordic Ecolabelling has checked that the information about the pulp is accurate and that the basic requirements set by Nordic Ecolabelling are complied with, e.g. chemical use, AOX, and fibre origin (Basic Module version 2 or later). Whether the paper production complies with the Ecolabelling requirements is determined by the mixture of pulps used and of the paper production data.

- We are aware that this inspection does not give us the right to use the logotype Nordic Ecolabel, nor advertise our pulp as Nordic Ecolabelled.
- We approve that the trade name and type of pulp, and producer of the inspected pulp, are published in Nordic Ecolabelling's database for paper producers (My Swan Account MSA).
- If application regards listing of inspected pulp on the Nordic Ecolabel website, we approve that the trade name, type and producer of the inspected pulp, are published there.
- We agree to use Nordic Ecolabelling's electronic application tool My Swan Account (MSA) for the application process. By logging in to MSA we confirm our acceptance to the User Agreement.
- We confirm that the above pulp(s) are produced only at the stated mill/place of production.
- We confirm that the companies' production fulfil the government regulations.
- We confirm that we know the contents of relevant module criteria for Nordic Ecolabelling paper products.
- We confirm the validity of the documentation that is specified in our application.
- We approve that Nordic Ecolabelling controls the requirements during the criteria validity time.
- We confirm that no changes of the production will be made that may jeopardize the fulfilment of the criteria without the permission from Nordic Ecolabelling.
- We confirm to immediately report any unexpected deviation which may affect the products ability to fulfil the Ecolabelling requirements.
- We confirm to perform annual reporting in MSA. We confirm to pay the different fees according to the Nordic Ecolabel regulations. [Read more about the fees here.](#)
