A guide to Nordic Ecolabel's Building Materials Database



Dear Building Materials Manufacturer,

Welcome to Nordic Ecolabel's Building Materials Database. By following the steps below, your product(s) will be visible to all Nordic Ecolabel licence holders and companies which currently are in the process of constructing a Nordic Swan Ecolabelled building.

When all the steps below have been completed, your product(s) will receive the status "Application registered". A Nordic Ecolabel environmental officer will go through all the details and documentation of your product. Once this is done, provided that your product fulfills Nordic Ecolabel's requirements, your product will receive that status "listed" and may be used in the construction of a Nordic Swan Ecolabelled building.

Before you start, please consult the <u>Product Matrix</u> in order to see whether or not your product should be listed in the Nordic Ecolabelling Portal. Only product types marked in <u>green</u> and with an X in the column *Nordic Ecolabelling Portal* should be registered and declared.


Do you want to register an entire "product family" with multiple but very similar products? This could be a range of flooring in 10 different colours or gypsum boards available in 5 different sizes. Then you can register the "family" as one product and specify which colours/dimensions/etc. are part of the family in the field "Add additional information of the product" (see step 2 below).



Start off by signing the agreement to get access to the Nordic Ecolabelling Portal. Scan and email the signed agreement to hus@svanen.se.


Once the contract has been signed and submitted, you will receive an account and will be able to log into the database to register and declare your products.

Start by clicking **Listed Products \rightarrow Add Listed Products** in the top menu.





You will now see this view.



Fill out the fields marked above:

Product name: This will be used to identify the product by you and by Nordic Ecolabelling. It will not be visible to portal users who are searching for products.

Product Subcategory: This field decides which declaration you will fill out in the next stage. Please check the <u>Product Matrix</u> to see which appendix you should use.


Manufacturer contact: Choose a name from the list. This is the person Nordic Ecolabelling will contact if needed.

Product Group: Choose a category from the dropdown menu. This will open up the field **Product Type**. If you can't find a good match in Product Type, try another Product Group to get more options for Product Type.

Add additional information of the product: Here you have the opportunity to further describe and market your product, as a service to the buyer. Please state details such as area of use (what type of surface your product should be used on, whether it's a product best suited for use outdoors or indoors etc.) and other unique selling points for your product, but keep the information short and clear. This information will be visible to your potential customers inside the portal. Here, you can also add information on different colours or sizes available.



Scroll down to fill out **Trade Name**s for your product, and in which countries it is marketed. The trade name is the name that will be visible to portal users. The trade name can be the same as the Product Name you provided in step 2. If possible, use the same product name as in your website to make it easier for your customer to understand which product is listed. By default, only products which are sold in the country where the portal user is located are shown. However, the portal user has the possibility to search for products sold in other countries.





Save your work as you go along to avoid that your work might be lost.





Once your progress has been successfully saved, the button **Declare your product** will appear. If it does not appear, check that all fields described in step 2 are filled out.

When clicking the **Declare your product** button you will get a pop-up window containing the declaration chosen in step 2 (Product Subcategory). If the declaration does not seem to be relevant to your product, please check that the appendix chosen in Product Subcategory in step 2 is the same appendix as indicated in the <u>Product Matrix</u>. Note that some product groups must be declared using more than one appendix, in that case you can print, fill out and upload declarations at the end of the first declaration.

Declaration 7 Declaration from the manufacturer of the chemical product test

This declaration applies to all chemical products used in construction work at the building site or by manufacturers of prefabricated construction elements. Chemical products used to construct any supplementary buildings, fences, decking, outdoor furniture, playground equipment and similar items are also included.

This declaration is completed and submitted by the manufacturer of the chemical product based to the best of his/her knowledge at the time of the declaration, also based on tests and/or declarations from raw material manufacturers, recipe and available knowledge of the




Start filling out the declaration and be sure to click the Save button often. To navigate through pages, use the arrows at the bottom of the page.


When you reach the end of the declaration, you will have the possibility to upload the required documents specified in the <u>Product Matrix</u>. This will typically be product specification sheets, test reports, additional signed declarations and safety data sheets.

Click Select to browse for the necessary file. If you need to upload more than one file, please click select again, after you have chosen the first file.





When you are finished selecting documents, please click **Upload**. It is also possible to add a link to e.g. a safety data sheet or the product description page on your website (remember to click Done).





When all files are uploaded, click **Save**, and then **Ready for Evaluation**. The button will then change to Regret – Ready for Evaluation. This means that the declaration is submitted and awaiting evaluation by Nordic Ecolabelling. Do not click the Regret button unless you want to change the declaration. Now you can close the declaration window. You will see the product in your product list, and its status will be **Application registered**. Remember to click Save again, at the bottom of the page where you filled out trade names.





Remind your customer, who asked you to list the product, to contact Nordic Ecolabelling about evaluating the product. When the product has been evaluated, its status will change to **Listed**, or in some cases **Listed with remarks**. This makes it visible in the Nordic Ecolabelling Portal, and it can be used in the construction of a Nordic Swan Ecolabelled building.



Please note: Should your product not fulfill Nordic Ecolabel's requirements for building products used in a Nordic Swan Ecolabelled building, it will get the status **Denied**. You will be notified about this in an e-mail and your product will not be shown in the database. Only Nordic Ecolabelling and you as the producer will see the Denied product.
